Terms and Conditions of Car Parking

1. An owner or lessee who occupies an apartment in **QUEENS** and owns a vehicle shall be issued with a transponder to operate the auto barrier.
2. All applicants are required to produce documentary proof of ownership and residence i.e. Vehicle Registration Car, Company Certificate Letter (for company car), Lease Agreement (if tenanted), insurance, etc. Residents are also requested to update their addresses in the vehicle log card before the collection date.
3. Each household is entitled to only one (1) transponder and additional transponder will be charged at **S\$53.50 inclusive of GST**.
4. 1<sup>st</sup> vehicle (**Transponder with YELLOW Label**) is allowed to park on any lots, 2<sup>nd</sup> or 3<sup>rd</sup> (**Transponder with BLUE Label**) are only allowed to park on Level 3 onwards of the Multi-Storey Car Park (MSCP).
5. The Management reserves the right to reject any application at its discretion. Applications, if approved will be subjected to cancellation at the Management’s discretion. The Management’s decision is final.
6. Resident is required to notify the Management when he has changed his vehicle.
7. Loss of transponder must be reported to the Management in writing immediately. The replacement cost for each transponder is **S\$53.50 inclusive of GST**.
8. A transponder shall be displayed prominently on the front right of a vehicle in order to operate the auto-barrier and the transponder is not transferable.
9. Visitors’ vehicles are not allowed to be parked overnight within the precincts of **QUEENS** unless prior written notice has been given and written approval has been obtained thereof from the Management.
10. Visitors’ vehicles are to be parked at lots designated for visitors, such as Open Car Lots and Multi-Storey Car Lots at Levels Three (3), Four (4) or Five (5).
11. All unauthorised vehicles parked in the Condominium or illegally parked will be clamped. An administrative of **S\$53.50 inclusive of GST** on each occasion will be charged to release the clamp. The Management shall not be responsible for any damage(s) caused to the vehicle during the course of clamping.
12. All vehicles parked in the Condominium are parked at the owners’ risk. The Management shall not be responsible for any theft, damage or misdemeanour caused to the vehicles and/ or their contents.
13. Residents shall ensure that no damage is caused to the fittings and fixtures in the carpark and shall be liable should any damage be caused.
14. All rules and regulations governing the car parking shall be observed at all times.
15. The Management reserves the right to make additions or alterations to the existing clauses as and when necessary.
